#### **ATTENTION LANDOWNERS**

Free Trees, Plastic Mulch, Drip Irrigation Program (Contingent upon federal approval of HELP's proposal)

The RM of Cana No. 214 has passed a council resolution showing moral support for HELP International's proposal for funding submitted to the federal government's Two Billion Tree Program. The R.M. will now be accepting applications to a maximum of seven (7) landowners to be pre-qualified for the program. Applications will be accepted on a first come, first serve basis. The next available programming year at this time is 2027. Dependent upon the timing of this RM meeting the number of required applicants and submitting to HELP, the programming years could be pushed back to 2028.

#### Each landowner receives:

- 1,000 woody species 2 year old trees of your choice both coniferous/deciduous;
  50 brush trees (lilac, cariganna, chokecherry, dogwood, buffalo berry, buckthorn, sand cherry)
  25 saplings
  5-7 ft (willow and poplar) sufficient for over
  3,000 meters of tree line.
- 1,500 meters of ½ inch drip line with pre-installed emitters or 7/8 inch drip line plus emitters; accessories valves and union elbows & filters
- 1,500 meters of free 3.2 mil plastic mulch film (Note that each landowner is given sufficient mulch film and drip line for roughly half of the 3,000 meters of tree line. The landowner is expected to utilize traditional weed control and irrigation for the half of the tree lines where mulch film and drip line is not installed.)
- training session and support from coordinator prior to planting
- contractor information available at landowner's expense if you cannot plant the trees yourself
- additional supplies can be purchased from HELP International
- All free forestry materials delivered free of charge from Weyburn to RM drop off point at a date requested by the group of seven applicants in the year they are approved for.

#### Your commitment:

APPLY as soon as possible to qualify for the 2027 program year. The program application is posted on the website and available at the R.M. office.

If the program funding is approved and this RM pre-qualifies by submitting seven applications, successful applications will:

- Prepare a site schematic and planting site (plant at 2.5 to 3 meters tree spacing ie. Rows of 3 x 1,000 meter rows, 4 x 750 meters, 6 rows x 500 meters. etc)
- Pick up free materials (and any additional purchased materials) at pre-planned drop-off site
- Plants trees
- Water and weed around trees until well established.

#### Options:

- Get all 1,075 trees, dripline and mulch at one time for yourself
- Share the 1,075 trees, 1,500 meters of mulch film and 1,500 meters of drip line with another landowner (Each landowner applies for their specific quantity of trees but it has to equal the above totals). Submit the applications together to the R.M. and state that you are sharing the materials.

#### Other:

- HELP International has a wealth of valuable information on shelterbelt planning on their website. HELP will also provide free telephone advice to landowners to assist in the planning of shelterbelt and planting for any other purpose ensuring to match the most appropriate trees for the landscape and soil conditions.
- Should producers or acreage owners require an on-site assessment and planning session, HELP will provide a one to two hour on-site for a cost of \$250.

HOWEVER, HELP is confident that federal government funding will be achieved. This promise recognizes the investment of hundreds of hours by RMs and landowners in RM and landowner mobilization, landowner planning and callins for consultations and education regarding this proposed program.
