Request to Fence Along Road Allowance

- **Chaban:** That the landowners of Parcel A, Plan 101670948 on the SE 11-23-6 W2 be authorized to install barbed wire fence on Range Road 2061 (the Road) on the East side Parcel A, Plan 101670948 with the following conditions:
 - A gate must be installed at the South end of the fence at Fairland Road;
 - The Public must be granted access to the Road if requested; and
 - The Municipality reserves the right to revoke this permission and require the fence removed at the landowner's expense should access to the Road be required for any purpose deemed appropriate by the Municipality.

Nuisance Complaint – Lots 28-29, Block 4, Plan W2614

Beres: That the Council for the R.M. of Cana No. 214 hereby declares the lands located on Lots 28-29, Block 4, Plan W2614 to be a nuisance under Section 1 and 14 of Bylaw No. 5-12 the Nuisance Bylaw for the following reasons:

- The land has a collection of miscellaneous junked materials, lumber, and debris located in the back;

That the Designated Officer is hereby authorized to issue an order to Jerry Yawney of the said properties requiring them to undertake the following work:

- Remove the miscellaneous junked materials and debris located in the back yard no later than 30 days from the date of the Order; and

That if the work noted is not completed by the date noted above, the municipality is authorized to take whatever steps necessary to complete the work and recover the costs.

Township Road 231

238/24 Chaban: That a letter be sent to the property owner of SE 8-23-6 W2 advising that the municipality is aware that bush work has occurred along Township Road 231 and further to advise that in accordance with Bylaw No.7-2016 written permission from the municipality is required before any works to a road allowance may occur.

<u>E & H Redi-Mix – Enforcement Order</u>

P. Yelle: That Administration be authorized to inform E&H Redi-Mix that to avoid further action under *The Planning and Development Act* and cancellation of Road Maintenance Agreement No. 2023-02 payment for materials extracted from Township Road 240 in accordance with Resolution 241/24 must be remitted to the municipality and remedial action to restore any development that is in contravention of the conditions of Development Permit 2023-07 pursuant to the Enforcement Order dated August 20, 2024 must be completed, including the reclamation of the NE 33-23-6 W2 and the restoral of the elevation of Township Road 240 to pre-contravention condition, and further that no excavation on the SE 4-24-6 W2 may commence until the remedial action is completed and payment for gravel is remitted.
